2. As per tender notification Pre-Bid meeting was held on scheduled date i.e. 27-06-2025 at 11:00 A.M at Corporate Office Jammu and Srinagar.
 - a. A Corrigendum was issued vide No: JKMSCL/Drugs/ Corg/ 663/2025/227-29 Dated: 16-07-2025 wherein few items were deleted and some were added in the Annexure C. It was also informed to the bidders that GST shall be applicable on Tender fee and processing charges @18% and they have to deposit the differential amount (total 11800/- instead of 10000)
 - b. Another Corrigendum was issued vide No: JKMSCL/Drugs/Corg/ 663/2025/2336 Dated: 23-07-2025 thereby again few items were added and few item codes were amended.
 - c. Further vide No: JKMSCL/Drugs/ Corg/ 663/2025/ 2393-96 Dated: 28-07-2025 another corrigendum was issued wherein few more items were added under Annexure "C" and three tendered items were deleted. It was made mandatory for the participating bidders/nominated dealer to execute supplies, to mandatorily disclose the bank account number which is linked with their GSTIN at the time of bid submission.
3. Scheduled date for receipt and opening of tenders were also extended from time to time upto 02-09-2025 and 04-09-2025 respectively.
4. Accordingly, e-bids were opened on 04-09-2025, in the presence of Technical Evaluation Committee constituted by Boards of Directors during ^{1st} Board Meeting and amended by Boards of Directors during ^{3rd} Board Meeting, JKMSCL for the purpose. Subcommittee pointed out that it was specifically mentioned under "Note" of Annexure "A" at Page No. 8 of NIT that:

1. In a tender either the Indian agent on behalf of the Principal/OEM or Principal/OEM itself can bid but both cannot bid simultaneously for the same item/product in the same tender.
2. If an agent submit bid on behalf of the Principal/OEM, the same agent shall not submit a bid on behalf of another Principal/OEM in the same tender for same item/product.

Clause 40 of NIT, conflict of interest clearly provides that:



- a) Bidder may be considered to be in Conflict of interest with one or more parties in bidding process if, including but not limited to:
 - a) Have controlling partners/shareholders in common; or
 - b) Receive or have received any direct or indirect subsidy from any of them; or
 - c) Have the same legal representative for purposes of the Bid; or
 - d) Have a relationship with each other, directly or through common third parties, that puts them, in a position to have access to information about or influence on the Bid of another Bidder, or influence the decisions of the Procuring Entity regarding the bidding process; or.....

During the scrutiny of the Technical Bids, it was observed that the above mentioned bidders had nominated the same legal representative (Authorized Agent). Additionally, certain items were found to be common among these bidders. Accordingly, the same was notified in the Minor Infirmities Notice referred to above.



8. Rest of the Bidders were declared technically qualified by the sub-committee.


