Please read the clauses as below:-

- a) Read as clause 3.4.2.16, as under: "In case of showdown(s) /agitation/ situation beyond control in Kashmir Valley, during the period of contract, the relaxation under class 3.4.2.13 shall be considered as "deemed fit by TIA subject to production of certificate from Head of the Departments of the indenting institute that "the situation is non-conducive to get the instrument maintenance and is recommended for relaxation with regards to the penalty clause(s).
- **b)** Under clause: 3.4.2.1 <u>Operationalization of Maintenance services</u> add a clause [g(a)] "for confirmation/verification with regards to repair of equipments system Generated verified report through e-upkaran shall be accepted for releasing the payments.
- c) Under clause 3.4.2.1 (Operationalization of Maintenance services will be regards as) (g) line no. 06 "subsequent quarter instead of subsequent year"
- **d)** Under clause 3.4.2.15 as 3.4.2.17 "Batteries, cable probes, tubing's, X-ray Tubes and allied items except disposable and consumable items shall be provided and replaced by the successful bidders within the quoted prices which shall be a part of contract". To further clarify it is stated that.
 - 1. All major/ minor maintenance/ servicing of Biomedical equipments and or replacement of spares in these equipments shall be responsibility of Service Provider.
 - 2. All consumables/disposables/spares which are replaced in day to day patient diagnostics or therapeutic activities may be born by the Authority. Examples are reagents/control solution / ECG papers/ Disposable ECG Electrodes/ Ultra sound Gels / Patient Circuits for Ventilators etc.
 - 3. However all the consumables/disposables/ spares which are required for smooth operations of the equipments will be born by the Service Providers. Examples are X-Ray tubes/ CT

Tubes/Helium replacement in MRI/SPO2 Probes/Patient Cables/ All kind of batteries/ Flow Sensors and Oxygen sensors etc in the Ventilator/All light sources like Xenon/ Halogen/LED/ All kind of fuses/wires/cables etc.

- e) Under clause 3.4.2.3 line No. 06 replace the line "Resolving/ fixing of the fault must be followed by the closure of communication loop (call closure) via telephonic guidance" WITH "Resolving/ fixing of the fault must be followed by closure of communication loop (call closure) via telephonic guidance/e mail guidance/SMS/soft-ware."
- f) Read clause: 3.4.2.9 (b) as" A report indemnifying equipment requiring condemnation should be submitted by the Maintenance Service provider once every year. The renewal of the contract shall be as per Annual performance."
- g) Under clause 3.6.2 (I) line No.06 READ "The bidder should submit details of financial capability for the last three (3) financial years (i,e FY 2013-2014,2014-2015 and 2015-2016)" in place of "The Bidder should submit details of financial capability for the last three (3) financial years (i.e. FY 2012-13, 2013-14 and 2015-2016) instead of 2012-13,2014-15, and 2015-2016".
- **h)** Under clause 3.9.1 Bid security (EMD) READ LINE "bid security of the successful bidder shall be retained" AS "bid security of the successful bidder shall be retained. till the submission of Performance Security and thereafter returned as per clause 3.19.4."
