Subject: Blacklisting /Debarring order in favour of M/s M. R. Healthcare Pvt. Ltd., Painth Parao, Near State Bank of India, Ramnagar, District Nainital (Uttarakhand).

Whereas, this office had issued various Purchase Orders to M/s M. R. Healthcare Pvt. Ltd. for supplying of drugs / hospital supplies meant for Supplementary Demand 2023-24, Annual Demand 2024-25, Supplementary Demand 2024-25 & Centrally Sponsored Schemes placed on 08-09-2023, 30-10-2023, 02-11-2023, 12-03-2024, 02-04-2024, 18-04-2024, 29-04-2024, 14-09-2024, 18-10-2024, 29-10-2024, 19-11-2024 & 30-11-2024 respectively and the following Purchase Orders issued by JKMSCL were not executed by M/s M. R. Healthcare Pvt. Ltd.:

Whereas, the following non-execution notices were issued against M/s M. R. Healthcare Pvt. Ltd.:

- i. JKMSCL/GM/P&S/2024/84-88 dated 24-04-2024

Whereas, despite lapse of considerable time M/s M. R. Healthcare Pvt. Ltd. failed to execute the above mentioned Purchase Orders;

Whereas, the clause with regard to refusal to supply and non execution of supplies as per JKMSCL Policy for Blacklisting /Debarring of Product or Company is reproduced as under:

3.3. If the supplier fails to execute the purchase order and informs JKMSCL about its inability to execute the order and non-compliance of the purchase order due to act of vis majeure, then the Managing Director, JKMSCL will issue appropriate order on merits of case.

3.4. If the supplier fails to execute at least 60% of the quantity of item mentioned in purchase order and such failure in supply continues for three purchase orders, then supplier firm will be liable for blacklisting for a period of not Less than 2 years. As a result such supplier will be ineligible to participate in any of the tenders for particular item(s) of drugs / medicines for a period of not less than 2 years or the period specified in tender document.

Whereas, the matter was placed before the Disciplinary Committee in its meeting held on 21-05-2025 and it was decided by the Committee that keeping in

view the Principle of Natural Justice a Final Show Cause Notice be issued to the above mentioned firm for seeking explanation in the matter;

Whereas, a Show Cause Notice was issued against M/s M. R. Healthcare Pvt. Ltd. vide No. JKMSCL/GM/DISC/2025-26/1867-74 dated 28-05-2025 for seeking explanation in the matter and in response the firm submitted as under:

"we are unable to supply the drugs as per the requirement, as our plant is in shutdown for the purpose of up-gradation in accordance to the requirements of Revised Scheduled M of Drugs & Cosmetics Act according to which all Drug manufacturers are mandated to comply the revised guidelines within a stipulated time period and the same was communicated to you in our earlier reply. Hence we request to kindly consider our position, as we will not be able to supply the requisite drugs, considering the unavoidable circumstances due to change in central government regulations."

Whereas, the firm has not executed a single Purchase Order resulting in disruption of supplies of critical drugs to the needy patients;

Whereas, the matter was again placed before the Disciplinary Committee in its meeting held on 14-06-2025 and the Committee is of the opinion that the reply of the firm is not satisfactory, as the non-execution of Purchase Order affected the patient healthcare. As the firm violated the Clause 3.3 & 3.4 of JKMSCL Policy for Blacklisting /Debarring of Product or Company, the Committee decided to blacklist the firm for a period of 02 years. Further, the EMD submitted by the firm against the said NIT be forfeited, if not available, the amount equivalent to EMD may be deducted from the payment lying with JKMSCL.

Therefore, keeping in view the above mentioned facts, M/s M. R Healthcare Pvt. Ltd, Painth Parao, Near State Bank of India, Ramnagar, District Nainital (Uttarakhand) is hereby blacklisted for a period of 02 Years from the date of issuance of this order and the EMD(s) submitted by the firm is/are hereby forfeited.
