CIRCULAR

Sub:-Deviation in the Procurement Guidelines by the end user Departments.

Jammu and Kashmir Medical Supplies Corporation Limited (JKMSCL) is a fully owned company of Government of Jammu and Kashmir sanctioned for establishment vide Govt. Order No. 329-HME of 2013 dated 22-05-2013, pursuant to the cabinet decision No. 130/15/2013 dated 21-05-2013 and is mandated for the procurement of Drugs / Medicines / Medical Equipments / Disposables / Dressing items Hospital furniture etc, for the Department of Health and Medical Educations other Health Institutions of J&K.

It has been observed that various end users / Health Institutions of J&K resort the procurement of Drugs/Medicines Equipments etc. at their own level and float the tenders even for the items which have the valid rate contract with JKMSCL. This practice has been viewed very seriously by the higher authorities as well.

Mere issuance of the non-availability of particular item(s) at a given point of time cannot by any means be construed as No Objection Certificate (NOC) to the indenting department for procurement at their own level. The procurement is to be carried out by the JKMSCL on the provided specifications of the end user. The end user may resort to the procurement at their own level only in case of very urgent situations for the items of emergent nature for which the Rate Contract is not available with JKMSCL only after the issuance of unambiguous NOC by the JKMSCL.

Therefore, all the HOD's of the Health and Medical Education Department are informed that the procurement at their own level should be avoided except in the rare conditions as mentioned above.
