
CIRCULAR

With reference to minutes of meeting held on 17-04-2016 under the Chairmanship of Secretary to Government, Health & Medical Education Department, J&K circulated vide No. GMCJ/PS/16/Minutes/Med/1158 dated 18-04-2016, it is enjoined upon all concerned mentioned against each to comply with directions issued through this circular:

1.	To ensure the issuance of single batch supply of fluids and drugs to the end users in the interest of Drug Safety and Patient Care.	i. Controller of Stores, Jammu. ii. Controller of Stores, Kashmir. iii. Medical Officer (K), JKMSCL. iv. In-charge Drug warehouses.
2.	i. No Drug/ fluid should be supplied to the indenting institutes till it has been declared as of "Standard Quality" and has been put to active mode from quarantine mode. ii. To ensure that every drug issued should indicate that the said molecules/ items has been declared as of "Standard Quality" by JKMSCL empanelled Labs and are in active mode, further all supplies should be accompanied by in house Quality Testing Report.	i. Controller of Stores, Jammu. ii. Controller of Stores, Kashmir. iii. Medical Officer (K), JKMSCL. iv. In-charge Drug warehouses.
3.	All the molecules/ items declared as of "Standard Quality" and are in active mode should be intimated to all In-charge Drug Stores and the controlling authorities till 100% switching over to e-aushadhi application.	i. Medical Officer (Quality Control) JKMSCL.
