## CORRIGENDUM

## Subject: E-Bid for finalization of Rate Contract of Drugs....Corrigendum thereof..

Reference: No. JKMSCL/Tend/Drug&Med/05/2017 dated 02-02-2017.

In continuation to previous corrigendums issued dated. 09-02-2017, 13-02-2017, 28-02-2017 and 01-03-2017 regarding the subject, please read:

- i) Wherever, "Sample Based" is written in the NIT as "Deleted".
- ii) Average Annual Turnover for the last three financial years certified / issued by "Central Excise Department/ Assessing Authority of the State/ Central Government" instead of "Central Government/ respective States".
- Under General Terms and Conditions of BID and Rate Contract at Point No. 19 Terms of Payment:

"6-On receipt of the prescribed consolidated invoice duly stamped and signed by authorized signatory and in house, GLP Certified & NABL accredited Analytical Laboratory Test Report regarding quality, the payment would be made within next 30 days of declaration of drug as of "Standard Quality" by JKMSCL empanelled Labs "

- iv) "GMP/WHO" instead of "GMP".
- v) In Instruction to Bidders as Point No. 20:

"JKMSCL shall have right to inspect/ to get inspected the manufacturing premises by a team of technical experts with regard to *Good Manufacturing Practices* or otherwise as required under Drug and Cosmetic Act 1940/1945 and Rules made thereof from time to time, any time before the release of payment. In case the manufacturing Units including SSI Units of Jammu and Kashmir fails to comply or reported to be not complying to the parameters under Drug and Cosmetic Act, JKMSCL have right to cancel the Rate Contract/ Supply Order if issued or to return the supplies, if received against any of the supply orders."

vi) In General Terms and Conditions of BID and Rate Contract at Point No. 23 of Packing and Insurance under Packing Specification:

"12- If the Supply Order issued by the Jammu and Kashmir Medical Supplies Corporation Limited for any item(s) is in a meagre quantity i.e. not suffice to form a batch size, the JKMSCL shall have right to give exemption with regard to "ART WORK", if deemed fit.

- vii) "The cost of Bid document & Tender Processing Fee's shall have to be deposited online in the Form of NEFT in the Corporations bank A/c No. 037304050000032 maintained at J&K Bank, Medical College, Jammu, IFSC Code JAKA0MEDJAM or by depositing the amount directly into the above account number under Clause 8 of Notice Inviting Bid (Page 3), however, if any firm has got the DD( Demand Draft) prepared for the said purpose upto the date of issuance of Corrigendum shall be considered as one time exemption and with regard to EMD it shall only be in the form of FDR/ CDR for 24 months."
- viii) In Declaration and Undertaking on Annexure E, point No. 2:
  "a) We certify that the rates (of quoted item) are reasonable and comparable to the rates quoted in other Corporations and Premier Institutions of the Country. b) It the quoted rates at JKMSCL are higher than the rates of the other Government institutions, the company shall provide justification which may or may not be acceptable to TIA (Tender Inviting Authority) for issuing the Rate Contract."
- ix) Under Annexure "A" Declaration Form cum Check List at point No. 28 as:

"Product wise 03 (three) year Market Standing of last three financial years"

Besides, the list of Drugs and its allied group is amended as per the recommendations of the technical panel as Annexure "C" and accordingly revised BOQ is uploaded.

Note: Please note that the rates quoted as per revised BOQ only shall be considered.
