Subject: Blacklisting /Debarring order in favour of M/s Health Biotech Ltd., SCO-162-163-164 (Top Floor), Indian Airlines Towers, Sector-34 A, Chandigarh-160036.

Whereas, this office had issued various Purchase Orders in favour of M/s Health Biotech Ltd. for supplying of drugs / hospital supplies meant for Supplementary Demand 2023-24, Annual Demand 2024-25 & Supplementary Demand 2024-25 placed on 16-10-2023, 30-10- 2023, 12-03 2024, 27-03-2024, 02-04-2024, 18-10-2024 & 06-11-2024 respectively and the following Purchase Orders were not executed by M/s Health Biotech Ltd.:

Whereas, the following non-execution notices were issued by JKMSCL against M/s Health Biotech Ltd.:

- ii. JKMSCL/GM/P&S/2024-25/5933-38 dated 20-07-2024
- iii. JKMSCL/GM/P&S/2024-25/6630-34 dated 29-07-2024

Whereas, despite of lapse of considerable time M/s Health Biotech Ltd. failed to execute the above-mentioned Purchase Orders;

Whereas, the clause with regard to refusal to supply and non-execution of supplies as per JKMSCL Policy for Blacklisting / Debarring of Product or Company is reproduced as under:

- 3.3. If the supplier fails to execute the purchase order and informs JKMSCL about its inability to execute the order and non-compliance of the purchase order due to act of vismajeure, then the Managing Director, JKMSCL will issue appropriate order on merits of case.
- 3.4. If the supplier fails to execute atleast 60% of the quantity of item mentioned in purchase order and such failure in supply continues for three purchase orders, then supplier firm will be liable for blacklisting for a period of not Less than 2 years. As a result such supplier will be ineligible to participate in any of the tenders for particular item(s) of drugs / medicines for a period of not less than 2 years or the period specified in tender document.

Whereas, the matter was placed before the Disciplinary Committee in its meeting held on 21-05-2025 and it was decided by the Committee that keeping in view the Principle of Natural Justice a Final Show Cause Notice be issued against M/s Health Biotech Ltd. for seeking explanation in the matter;

Whereas, a Show Cause Notice was issued against M/s Health Biotech Ltd. vide No. JKMSCL/GM/DISC/2025-26/1923-30 dated 30- 05-2025 and in response the firm submitted that 07 days time period for compilation of documents and detailed reply be granted;

Whereas, till 14-06-2025 M/s Health Biotech Ltd. did not submit the detailed reply to the above mentioned Show Cause Notice issued by JKMSCL dated 30-05-2025;

Whereas, the percentage execution of the POs by the firm is considerably less than 60% (i.e 44.01%) and some of them have not been executed for a more than a period of one and a half year;

Whereas, further it has been found that out of ten POs, only two POs have been executed in full and one partially (41.25%);

Whereas, there have been consistent default of nonexecution for more than three Purchase Orders;

Whereas, the matter was again placed before the Disciplinary Committee in its meeting held on 14-06-2025 and it was decided by the Committee that since the firm violated the Clause 3.3 & 3.4 of JKMSCL Policy for Blacklisting / Debarring of Product or Company and also did not submit the reply despite of lapse of considerable time, the Committee decided to blacklist the firm for a period of 02 years. Further, the EMD submitted by the firm against the said NIT be forfeited, if not available, the amount equivalent to EMD may be deducted from the payment lying with JKMSCL;

Whereas, M/s Health Biotech Ltd. not only violated the Terms & Conditions of NIT /SPP but has also hampered the patient care, by not executing the Purchase Orders issued by JKMSCL;

Therefore, keeping in view the above mentioned facts, M/s. Health Biotech Ltd., SCO-162-163-164 (Top Floor), Indian Airlines Towers, Sector-31 A, Chandigarh-160036 is hereby blacklisted for a period of 02 Years from the date of issuance of this order and the EMD(s) submitted by the firm is/are hereby forfeited.
