Whereas, this office had issued various Purchase Orders in favour of M/s Hetero Healthcare Limited for supplying of drugs / hospital supplies meant for Supplementary Demand 2023-24, Annual Demand 2024-25 & Supplementary Demand 2024-25 placed on 16-10-2023, 30-10-2023, 12-03-2024, 02-04-2024, 31- 05-2024, 18-10-2024 & 29-10-2024 respectively and

the following Purchase Orders were not executed by M/s Hetero Healthcare Limited:

Whereas, the following non-execution notices were issued by JKMSCL against M/s Hetero Healthcare Limited:

Whereas, despite lapse of considerable M/s Hetero Healthcare Limited failed to execute all the above mentioned Purchase Orders;

Whereas, the clause with regard to refusal to supply and non-execution of supplies as per JKMSCL Policy for Blacklisting / Debarring of Product or Company is reproduced as under:

- 3.3. If the supplier fails to execute the purchase order and informs JKMSCL about its inability to execute the order and non-compliance of the purchase order due to act of vismajeure, then the Managing Director, JKMSCL will issue appropriate order on merits of case.
- 3.4. If the supplier fails to execute atleast 60% of the quantity of item mentioned in purchase order and such failure in supply continues for three purchase orders, then supplier firm will be liable for blacklisting for a period of not Less than 2 years. As a result such supplier will be ineligible to participate in any of the tenders for particular item(s) of drugs / medicines for a period of not less than 2 years or the period specified in tender document.

Whereas, the matter was placed before the Disciplinary Committee in its meeting held on 21-05-2025 and it was decided by the Committee that keeping in view the Principle of Natural Justice a Final Show Cause Notice be issued to the above mentioned firm for seeking explanation in the matter;

Whereas, a Show Cause Notice was issued against M/s Hetero Healthcare Limited vide No. JKMSCL/GM/DISC/2025-26/1867-74 dated 28-05-2025 for seeking explanation in the matter;

Whereas, till 14-06-2025 M/s Hetero Healthcare Limited did not submit the reply to the above mentioned Show Cause Notice issued by JKMSCL dated 28-05-2025;

Whereas, the matter was again placed before the Disciplinary Committee in its meeting held on 14-06-2025;

Whereas, in the meantime M/s Hetero Healthcare Limited submitted its reply on 16-06-2025 and the same was circulated among the members of Disciplinary Committee, so that the necessary decision in the matter shall be taken;

Whereas, the reply was not found satisfactory and it was decided by the Disciplinary Committee that since the firm violated the Clause 3.3 & 3.4 of JKMSCL Policy for Blacklisting / Debarring of Product or Company, the Committee decided to blacklist the firm for a period of 02 years. Further, the EMD submitted by the firm be forfeited, if not available, the amount equivalent to EMD may be deducted from the payment if any lying with JKMSCL;

Whereas, M/s Hetero Healthcare Limited not only violated the Terms & Conditions of NIT /SPP but has also hampered the patient care, by not executing the Purchase Orders issued by JKMSCL;

Whereas, the percentage execution of the POs by the firm is considerably less than 60% (i.e 21.84%) and some of them have not been executed for a more than a period of one and a half year;.

Whereas, further it has been found that out of fourteen POs, only two POs have been executed and there have been consistent default of non-execution for more than three Purchase Orders;

Therefore, keeping in view the above mentioned facts, M/s Hetero Healthcare Limited, Sy. No.-80-84, Melange Towers, 4 th Floor, C-Wing, Patrikanagar, Madhapur - Hyderabad is hereby blacklisted for a period of 02 Years from the date of issuance of this order and the EMD(s) submitted by the firm is/are hereby forfeited.
