Subject: Debarring/ Blacklisting of M/s Brij Textiles, 68, Khyber pass, Civil Line New Delhi.

Whereas, vide this office Rate Contract No. JKMSCL/Dressing/2020/369/16805-08 dated 19-03-2021 M/s Brij Textiles was declared as L1 bidder for procurement of Bandage Rolled F-II size 15cmx5meter as per the approved rates and in light of the prescribed specifications and terms & conditions of the NIT No. JKMSCL/MED/2020/369 Dated. 24-01-2020;

Whereas, this office had issued various purchase orders in favour of M/s Brij Textiles for supplying the Dressing Material items to JKMSCL.

Whereas, as reported by JKMSCL Quality Control Section, Jammu, three batches of Rolled bandage size 15cm x 5meter (as per schedule F-II of Drugs and Cosmetic Act, 1940) manufactured by M/s Brij Textiles have been declared as "Not of Standard Quality" (NSQ) by two empanelled laboratories of JKMSCL (each): -

- 1) Batch no: 168; DOM: 12/ 2022; DOE: 11/2025.
- 2) Batch no: 021; DOM: 06/ 2023; DOE: 05/2026.
- 3) Batch no: 017; DOM: 05/ 2023; DOE: 04/2026.

The details of above NSQ batches are as under: -

Whereas, vide letter No. JKMSCL/QC/SGR/2022-23/80-88 dated. 15-02-2023 and letter no. JKSMCL/QC-K023/813-21 dated 01-08-2023, the firm was conveyed that their samples of Bandage Rolled F-II size 15cmx5meter were declared as Not of Standard Quality and further the firm was also asked to explain their position and provide the requisite information within weeks' time positively.

Whereas, in response to this office communication mentioned above, the firm vide reference no. BTX-DRUG/2023-24/039 Dated 05-08-2023 made a request to JKMSCL to take a lenient view in the matter since the product is not a drug for internal consumption and is just used to cover the wound/ affected area indirectly;

Whereas, the matter was placed before the Disciplinary Committee, JKMSCL on 27-04-2024 for examination and after threadbare discussion, Committee was of the view that reply submitted by the firm is not satisfactory as JKMSCL cannot take lenient view in the instant matter and committee decided further to serve a show Cause notice to the said firm in this regard.

Whereas, a Show Cause Notice was served to M/s Brij Textiles vide No. JKMSCL/Adm/2024/ CC-7458754/756-60 dated 02-05-2024 with the directions to explain the position regarding the above mentioned facts. The firm replied to the Show Cause Notice on 12-05-2024 through email and the same was placed before the Disciplinary Committee in its meeting held on 21-05-2024. After examining the reply of M/s Brij Textiles, it was decided by the Committee that the submission made by the firm is matter of record and needs to be checked before proceeding further in the matter.

Whereas, after going through the reply of M/s Brij Textiles it was found that the firm alleged "that most of the laboratories empaneled with JKMSCL are not recognized under the Medical Devices Rules and therefore, tests performed by an unauthorized laboratory are also bad in the eyes of law".

Whereas, as per the record available /provided by Quality Control Section of JKMSCL it was found that the empanelled laboratories, which performed the tests of in-question items are having valid license for testing of Surgical Dressings issued by concerned Authority.

Whereas, the matter was again placed before the Disciplinary Committee in its meeting held on 03-09-2024 for further examination and it was decided by the Committee to debar the in-question product manufactured by M/s Brij Textiles for a period of two (02) years;

Whereas, the relevant clause of Policy for Blacklisting / Debarring of Product / Company is re-produced as under:

Clause 4.6: *If three batches of a particular item supplied under a tender tenure by the supplier are declared as Not of Standard Quality during its entire shelf life by an empanelled lab or Govt. Lab in test for assay and / or in any other parameter(s) and if such failures are further confirmed by another empanelled lab or Govt. Lab during its entire shelf life, the particular item of the drug shall be liable for blacklisting for a period of not Less than 2 years.*

Therefore in view of the above facts, it is hereby ordered that M/s Brij Textiles, 68, Khyber pass, Civil Line New Delhi is hereby **blacklisted /debarred from JKMSCL for the item "Bandage Rolled F-II size 15cmx5meter" for the period of 02 years from the date of issuance of this order** in light of clause 4.6 of the policy for blacklisting /debarring of product or Company and Terms & conditions of the NIT/Rate Contracts. It is further ordered that the EMD submitted by the firm is also forfeited forthwith.
