## Subject: - Blacklisting/Debarring of firms on the basis of Non Execution of Supply Orders—Revoke of Previous Order thereof.

Order No.: - 127 of 2018

Whereas, M/s Jajoo Surgicals, opp. C-21Mall, A.B. Road, Indore (MP) was debarred by J&K Medical Supplies Corporation Ltd. for two years vide this office Order No. 83 of 2017 dated 14-01-2017.

Whereas, authorized representative of said firm made written request and through personal appearance for revoking of order dated 14-01-2017 on the following grounds: -

- 1. That Debarring of firm as a whole is against the express policy of JKMSCL.
- 2. That both the supplies (against PO Order No. 10281601431 & 10281601432) were executed in full and even the material was dispatched, alongwith invoice, GR and other documents, during the period stipulated in supply order.
- 3. That due to disturbance that ransacked state, especially Kashmir Valley during that year, these supplies were delivered late at the respective Drug Ware Houses of JKMSCL.

Whereas, Medical Officer In-charge Drug Ware House, Srinagar and Regional Drug Ware House, Nagrota has verified that the consignment has been relieved in time and supplies were uploaded on E-Aushadhi later on.

Whereas, General Manager (P&S) also acknowledged the receiving of 70% Supplies in time but uploaded on E-Aushadhi later on.

Whereas, Clause 3 of Procedures and Policies/Guidelines details with Blacklisting/Debarring of Product or Company and as per Clause 3.4, if the supplier fails to execute at least 60% of the quantity of item mentioned in purchase order and such failure in supply continues for three purchase orders, then supplier firm will be liable for blacklisting for a period of not less than two years. As a result such supplier will be ineligible to participate in any of the tenders for particular item(s). of drugs/medicines for a period of not less than two years.

Whereas, vide this office order no. 83 of 2017, dated 14-01-2017, the firm as a whole was debarred for a period of two years against the above Stated Policy as claimed by the M/s Jajoo Surgicals and requested for revocation.

Whereas, as per Clause 7 of policy for Blacklisting/Debarring of Product or company authorizes the Managing Director of JKMSCL to review earlier action(s). Also clause 6.1.6 (2) of Standard Procurement (SPP) for unexecuted supplies prescribes procedure for alternate supply as mentioned in

Clause 7.25.7 & 7.26.7 or levying penalty @ 20% on value of unexecuted supply which is more or debarring the firm for the said products as deemed fit, to the TIA.

Therefore, in view of above, request of M/s Jajoo Surgicals, opp. C-21Mall, A.B. Road, Indore (MP) is considered and found to be based on facts viz a viz a policy of JKMSCL in this regard non execution of supplies. Accordingly, the Order No. 83 of 2017 dated 14-01-2017 is reviewed and revoked as under: -

"The name of M/s Jajoo Surgicals, opp. C-21Mall, A.B. Road, Indore (MP) is hereby withdrawn from Order No. 83 of 2018 dated 20-01-2018 issued by J&K Medical Supplies Corporation Ltd. under endorsed No. JKMSCL/PS/MD/2017/6870-82 dated 14-01-2017, ab-initio".
