ADDENDUM

- 1.) Responsibility of Successful Bidder: The successful bidder shall be sole responsible for safety and security of the operational vehicles and their equipments and the damages due to their staff during the contract period, failing which the same cost involved shall be deducted from their legitimate monthly bills. Selected bidder shall ensure that the ownership of Government of Jammu and Kashmir in assets created out of Government Fund is protected. Responsible for compliance of the statutory requirements under any law in force. The bidder shall be held responsible in case of any penalty, loss or other legal consequences arising out of non-compliance or the loss caused by the strike of their own staff, whatever the reasons be.
- 2.) During breakdown of ambulance due to any damages, firm shall responsible for immediate rectification of defect of vehicles / equipments within 48 hours positively on site otherwise a sum of Rs.1000 per Ambulance per day shall be recovered from the firm as penalty from the date of intimation, this shall be in addition than the penalty already envisaged in NIT clause Response Time clause "b"
 - 3.) Inspections: Payment in respect of operational expenses of Call Centers shall be released on monthly basis after successful set-up and commissioning of same based on the evaluation reports from the inspection committee followed by monthly verification reports from the nodal officers of the concerned Directorates. Likewise, payment in respect of operational expenses of ambulances shall be released on monthly basis after successful commissioning of same based on performance evaluation reports from nodal officers of the concerned Directorates.
 - 4.) Irregular assigning of calls: It has been observed that the calls are routed to far off ambulances resulting in delayed response time and multiple calls are assigned to same ambulance while its still exacting a previous call. The staff in the control room has to be sufficiently trained so that assignment of calls be maintained properly, penalty shall be imposed as deemed fit by the department if defaulted .All the delayed responses shall be converted to impossible penalties, to prevent such mistakes. Further the department shall be at liability to access the capabilities of any paramedic deploy in the control room.

5.) The operator shall be responsible to pay wages to their staff in time even if their payments are not cleared by the department in due time to any reason. This shall avoid strike by the staff.
