Subject:-Debarring/Blacklisting of M/s International Institute of Professional Studies, Khanyar, Srinagar.

Whereas, the tender for finalization of rate contract for supply of different category(ies) of manpower including Assistant Programmer for JKMSCL was floated by Jammu & Kashmir Medical Supplies Corporation Ltd. vide tender number No: JKMSCL/Manpower/2020/425, dated 15-10-2020.

Whereas, technical bid was opened on 02-11-2020 wherein twelve(12) bidders participated and after preliminary evaluation of the documents of the bidders the sub committee submitted its report to Technical Evaluation Committee constituted vide Order No: JKMSCL/FA/2020-21/1396-99 dated 28-10-2020.

Whereas, minor infirmities were asked from the participating firms/bidders vide No: JKMSCL/GM/Adm/2020/5363-66, dated 21-11-2020.

Whereas, out of the 12 bidders, only 10 bidders were technically qualified for opening of their Financial Bid and were recommend for the opening of their Financial Bid by the Technical Evaluation Committee.

Whereas, the meeting of the Financial Evaluation Committee was held on 27-11-2020 wherein financial bid of the eligible bidders was opened and M/s International Institute of Professional Studies, Khanyar, Srinagar stood L1 bidder(Re 0.012).

Whereas, the meeting of the Purchase Committee of JKMSCL was held on 28-11-2020, wherein rates offered by L1 bidder i.e M/s International Institute of Professional Studies, Khanyar, Srinagar were approved.

Whereas, the Purchase Committee in its meeting decided that in order to safeguard the performance of the contract, in view of the meager rates quoted by the bidder, an undertaking in the shape of an affidavit guaranteeing the successful performance of the contract shall be taken from the L1 bidder who shall be kept on three month's time probation and extension shall be granted only after gauging the overall performance.

Whereas, LOI was issued to M/s International Institute of Professional Studies, Khanyar, Srinagar vide No: JKMSCL/GM/Adm/2021/6080-86, dated 06-01-2021 wherein the concerned firm was allotted the job as per the decision of the Purchase Committee on probation period of 03 (three) months with effect from 01-01-2021 and was asked to submit an undertaking in the shape of an affidavit within 05 days of the issuance of the LOI assuring therein the successful performance of the contract, before issuance of the formal contract and in case of satisfactory performance during the said period the contract may be extended.

Whereas, M/s International Institute of Professional Studies, Srinagar instead of submitting the affidavit submitted a letter received via email on 15-01-2021 vide No: IIPS/JK/JKMSCL/TDR/MP/01/2021 dated 08-01-2021, therein requesting to issue orders on top priority basis for modification/change of the terms and condition of the NIT with regard to the payment to the firm.

Whereas, JKMSCL in its reply to the concerned firm vide No: JKMSCL/FA/CAO/2021/1982-87 dated 19-01-2021 clarified that the terms and conditions of the (Tender) NIT cannot be amended or changed at this stage and also informed the concerned that the firm has submitted the tender only after accepting the tender conditions and was asked to submit the required affidavit within a day.

Whereas, the concerned firm submitted an undertaking in the shape of an affidavit on 21-01-2021 wherein among other conditions the firm added two new conditions at serial No: 4& 5 of the affidavit stating



- (4) that they shall continue to work in accordance to their previous precedence and shall continue to make payments to hired employees in accordance to the terms and conditions as already in existence with the employees.
 - (5) that due to the turmoil in the UT after abrogation of Article 370 and situation created by COVID-19 temporary relaxation may be granted for release of advance payment on part of JKMSCL.

Whereas, the concerned firm has not submitted the undertaking in consonance with the decision of Purchase Committee and has purported to work in accordance with previous precedence only, accordingly, it was decided to approach L2 bidder to match L1 rates.

Whereas, the Purchase Committee meeting of J&K Medical Supplies Corporation Ltd. was held on 27-01-2021 wherein among various other decisions, the General Manager (Adm) was permitted to issue Letter of Information (LOI), enter into an agreement and issue rate contract to L2 Bidder on matched rates of L1.

Whereas, the Purchase Committee in its meeting held on 27-01-2021, also approved debarring/blacklisting of L1 bidder (M/s International Institute of Professional Studies, Srinagar) from participating in the future tenders issued by the JKMSCL for period of two years.

As per the policy for Blacklisting/ Debarring of Product or Company under clause-2 read with sub-clause-2.1

"The successful tenderer fails to execute the agreement after being declared as L1,L2,L3 etc. to perform the obligations under the tender conditions, the firm shall be liable for blacklisting for a period of not less than two(2) years or the period specified in the tender document".

The action as per "Policy for Blacklisting/Debarring of Product or Company" under clause-2, on account of failure to enter into the agreement or refusal/failure to perform the obligations under the tender conditions read with sub-

clause 2.1 needs to taken against the firm i.e. M/s International Institute of Professional Studies, Behind Gousia Hospital, Khanyar, Srinagar.

Therefore, it is hereby ordered that firm M/s International Institute of Professional Studies. Behind Gousia Hospital. Khanyar, Srinagar debarred/blacklisted from JKMSCL for 02(Two) years with immediate effect.
