Subject: Blacklisting/Debarring Order in respect of M/s Health Biotech Ltd., SCO-162-163-164 (Top Floor), Indian Airlines Towers, Sector-34A, Chandigarh - reconsideration thereof.

ORDER NO: 02-JKMSCL of 2026

Whereas, vide Order No. 34-JKMSCL of 2025 dated 18-06-2025, M/s Health Biotech Ltd. was blacklisted for a period of two years on account of non-execution of various Purchase Orders and failure to respond to the Show Cause Notice, thereby violating Clauses 3.3 and 3.4 of the JKMSCL Policy for Blacklisting/Debarring of Product or Company; and

Whereas, M/s Health Biotech Ltd. challenged the said Order before the Hon'ble High Court of Jammu & Kashmir and Ladakh at Jammu vide WP(C) No. 2307/2025, and the Hon'ble Court, while disposing of the petition, granted liberty to the petitioner to file a representation before JKMSCL within ten (10) days and directed that the same shall be considered after affording the petitioner an opportunity of being heard and a decision taken in accordance with law; and

Whereas, in compliance with the directions of the Hon'ble Court, the firm submitted a representation vide No. HBL/RE/2025/0209 dated 02-09-2025, which was examined in detail by the Disciplinary Committee constituted for the purpose; and

Whereas, the firm was afforded an opportunity of personal hearing on 25-09-2025 vide communication No. JKMSCL/DISC/2025-26/6269-76 dated 20-09-2025, and its authorized representative appeared before the Committee and presented submissions, which were duly considered; and


Whereas, after careful examination of the records, representation and submissions of the firm during the personal hearing, the Disciplinary Committee, in its meeting held on 18-10-2025, observed that while the grounds cited by the firm were not legally tenable, certain mitigating factors warranted reconsideration of the overall blacklisting order. The Committee accordingly recommended that the general blacklisting of the firm be revoked, however, the blacklisting/debarring be continued specifically in respect of the item Inj. Etoposide 20 mg/ml, 5 ml Vial due to non-execution of supplies, which adversely affected patient care; and

Now, therefore, in view of the above and in pursuance of the recommendations of the Disciplinary Committee, it is hereby ordered that:

1. Order No. 34-JKMSCL of 2025 dated 18-06-2025 issued by JKMSCL debarring/blacklisting M/s Health Biotech Ltd. for a period of two (02) years

is hereby revoked ab-initio; however, the blacklisting/ debarring shall continue to remain in force only for the product "Inj. Etoposide 20 mg/ml, 5 ml Vial," on account of non-execution of supplies, thereby directly impacting patient care for the period of 02 years from the date of issuance of above mentioned Order dated 18-06-2025.

2. The firm shall henceforth remain eligible to participate in all future tenders of JKMSCL, except for the above-mentioned product, subject to fulfillment of the tender terms and conditions.
