The Jammu and Kashmir Medical Supplies Corporation Ltd, invites e - tenders from reputed & eligible firms within Union of India engaged in manufacturing / trade for the supply of Peer Educator Kits (containing one T-Shirt, one Cap & one Badge) for implementation of Rashtriya Kishore Swasthya Karyakram (RKSK) under National Health Mission in the state of J&K.

#### **I. TENDER PROCESS:-**

1. The Tender shall be under two cover system comprising of Technical Bid and Financial Bid.
2. The tender form along with detailed terms and conditions shall be available for downloading from the website [www.jktenders.gov.in](http://www.jktenders.gov.in), [www.jkhealth.org](http://www.jkhealth.org), [www.jknrh.com](http://www.jknrh.com), [www.jkmscl.nic.in](http://www.jkmscl.nic.in), [www.jkmsclbusiness.com](http://www.jkmsclbusiness.com)  
The cost shall have to be paid irrespective of whether the document has been downloaded or a hard copy has been taken. **The bidders shall have to upload the scanned copy of Cash receipt or DD towards the cost of tender document along with technical bid.**
3. E-tenders shall have to be uploaded on or before 09.02.2016 upto 16.00 hrs p.m. It shall be the responsibility of the bidder to ensure that the documents complete and correct in all respects in accordance with the terms & conditions laid down in this tender are uploaded.

4. The duly filled tender form in the proforma prescribed in ANNEXURE-I ( Tech bid) & II (Financial bid), complete in all respects should be uploaded to [www.jktenders.gov.in](http://www.jktenders.gov.in) on or before 09.02.2016 upto 14.00 hrs after which uploading shall be disallowed. **No tender(s) sent by post / courier shall be accepted.**

5. The bidder shall be required to upload the Tender Document along with other requisites and shall put digital signatures on the uploaded documents as a token of having read and understood the Terms and Conditions contained therein.

6. The bidder should fill up the information in the Annexure enclosed at the end of this document in clear and legible terms. Wherever required, copies of the supporting documents in respect of the details mentioned in the annexure should be uploaded. ANNEXURES - I & II and all the supporting documents shall have to be self attested and stamped by the bidder.

7. Earnest Money Deposit of Rs. 50,000/- (Fifty thousand only) in the form of Demand Draft drawn on any nationalised/scheduled Bank in favour of Jammu and Kashmir Medical Supplies Corporation Ltd , payable at Jammu shall have to be submitted with every bid. The scanned copy of the EMD must be uploaded with the technical bid. Technical bids without scanned copy of Earnest Money Deposit will be rejected. EMD will be returned to all the unsuccessful bidders at the end of the selection process. However, the EMD shall be forfeited in case the successful bidder withdraws after being selected. No interest shall be paid on the Earnest Money Deposit.

**8. The Demand Draft as the cost of tender document, tender processing fee & FDR/CDR as EMD shall also have to be submitted in original to the office of JKMSCL at or before 14.00 hrs on 08.02.2016 ( Two days before opening of technical bid) positively failing which bid shall be considered as non – responsive.**

9. The tender forms incomplete in any respect shall be out rightly rejected.

10. The Technical bids complete in all aspects shall be scrutinized by the committee constituted for the purpose and Financial Bids of only those who qualify in the Technical Bid shall be opened. The date for opening of Financial Bid shall be declared after opening of technical Bid and the

venue for opening of bid shall be Corporate Office at Plot No 09, Transport Nagar, Narwal, Jammu, J&K.

**11. Opening and Evaluation of tender: -**

The Technical bids uploaded will be opened by the tender opening committee on 10/02/2016 at 11.00 a.m in the presence of bidder(s) or their representative/s who wish to attend. The representative(s) of the bidder(s), must carry a letter of authority with a photograph duly attested by the MD / Proprietor of the company / firm. Only those Technical bids which are found complete in all respect shall be eligible for scrutiny. The technical bids will be evaluated in the light of the eligibility criteria and submission of documents required for the tender as per terms and conditions. The inspection of the Dealer/firms premises or/and enquiry from the clients for whom said items of work(s) have been successfully completed / supplied for the year 2013-14 & 2014-15, will be done by the committee (if needed) at any time after the opening of the Technical Bid. After technical evaluation, the list of the successful bidders shall be uploaded on the website [www.jktenders.gov.in](http://www.jktenders.gov.in). The date for opening of financial bids will be declared after the evaluation of technical bid. The decision of Managing Director, JKMSCL shall be final regarding the evaluation of both technical and financial bids.

**12. Details to be furnished: -**

- a) All particulars must be furnished as asked for in the prescribed formats for technical and financial bids in the bid document.
- b) The bidder should not impose any counter condition and in such case tender shall be summarily rejected.
- c) All the information in the prescribed format as required for the technical as well as financial bid must be furnished otherwise the bid is liable to be rejected.

**III. TECHNICAL BID:-**

1. All Technical bids shall be accompanied with all the forms as given under Annexure- I (Technical bid)
2. The tender documents not uploaded in prescribed formats and not accompanied with scanned copy of EMD and cost of Tender Document shall be disqualified.
3. The details as required in the Technical bid forms shall be provided by the Dealer/firm to the Corporation and no self-made condition or counter conditions shall be put anywhere by the bidder. Bids with any such insertions shall be out rightly rejected.
4. **Eligibility Criteria for Technical bid:-**
  - a. Bidder must have Sales Tax Registration with latest certificate for clearance of all dues from the Sale Tax department. Evidence should be enclosed.
  - b. The bidder must have obtained Permanent Account Number (PAN) under the Income Tax Act, 1961. Evidence should be enclosed.
  - c. The evidence for filing of tax returns along with Profit and Loss Account and Balance Sheet for the Financial Year 2013-14 (Assessment Year 2014-15) should be enclosed along with the Technical bid.
  - d. The bidder must have at least 02 years experience in the manufacturing / trade in the field and must have been in receipt of gross contractual receipts of Rs Twenty lakh and above during the Financial Year 2013-14 & 2014-15 (Assessment Years 2014-15 & 2015-16).



- e. A statement showing the list of atleast 05 clients for the past 02 years along with their successful completion certificate(s) and contractual receipts as evidence, should be enclosed along with the Technical bid. The bidder shall also have to submit samples of the Items specified in Section- II above for assessment by the Technical bid opening committee. The clients and gross receipt which pertain only to specified trade shall be considered. Clients and receipts pertaining to any other activity should not be mixed in the statements provided.
  - f. Bidder should not have been convicted of any criminal offence related to professional misconduct or making of false statement or misrepresentation as to their qualifications. An Affidavit to the effect shall have to be submitted.
  - g. The firm blacklisted by any Govt. department or corporation or Govt. undertaking or any other agency shall not be eligible for bidding. **Every bidder would be required to submit an affidavit to the effect that the firm has never been blacklisted by any Govt. department/ Govt. undertaking/any other agency.**
  - h. The tenders shall remain valid for a period of 60 days from the date of opening of tender.
- 5. Based on the above terms and conditions mentioned in Technical Bid Form-I, the Technical bids shall be scrutinized and the bidders will be shortlisted for opening of financial bids.
  - 6. List of bidders who qualify for opening of financial bids shall be uploaded on [e. portal](#) and they shall be required to submit all documents, which have been uploaded with the technical bid, in original for verification within 05 days of such notification.
  - 7. Any deviation found between original and uploaded documents shall be a ground for out right rejection of the bid.
  - 8. JKMSCL reserves the right to change any of the terms and conditions prior to the last date for submission of bids.

#### **IV. FINANCIAL BID:-**

- i. The bidders shall be required to submit their financial bids in the prescribed format ( BOQ) as per Annexure ó II.
- ii. The financial bid shall have to be uploaded on to the site [www.jktenders.gov.in](http://www.jktenders.gov.in) by or before 09.02.2016, 1600 hrs.
- iii. The date of opening of financial bids shall be announced after the scrutiny of technical bids and preparation of list of valid technical bids.

- iv. The rates should be quoted in Rupees for per unit i.e Complete Peer Educator Kit; containing one T ó shirt, one Cap & one Badge (along with packing).
- v. The Lowest Financial Bid (L1) will be awarded the contract. L1 shall be decided on the basis of lowest total amount( inclusive of all Taxes, levies, entry tax etc.) quoted at annexureóII (financial bid). Negotiations may be held with L1 as well as L2 & L3 to arrive at matched L1.

**Note:** Order(s) to matched L1 shall be placed only in case of default or inability of the L1 supplier to deliver the item(s) as per the Implementation / delivery schedule.
- vi. **The price quoted should be inclusive of all taxes, duties, license fees, road permits etc incurred in supplying the Peer Educator Kits and should in no case exceed Rs 350/- per Kit.**
- vii. The price quoted shall be valid for a period of one year.
- viii. Price Preference to SSI units of J&K State only shall be allowed as per the Industrial Policy of Department of Industries and Commerce Government of Jammu and Kashmir in force at the time of opening of Financial bids on the production of documentary evidence / certificate issued by GM,DIC of the respective district.

#### **V. PERFORMANCE SECURITY:-**

The successful bidders shall be required to deposit performance security @ 05% of the total value of the contract within 7 days( excluding holidays) from the date of the award of the contract. Further, the performance security shall be accepted only in the form of Demand Draft drawn on any of the Scheduled Banks, in favour of Jammu & Kashmir Medical Supplies Corporation Ltd, payable at Jammu. If the successful bidder fails to remit the performance security within the prescribed time, the EMD remitted by him shall be forfeited. The performance security shall be released one month after the successful performance of the contract and final payment by JKMSCL to the successful bidder.

## **VI. AGREEMENT DEED / SIGNING OF CONTRACT:-**

- i. The successful bidder/s shall be required to execute an agreement for the fulfillment of the contract on Rs. 100/- non-judicial stamp paper within 3 days from the date of submission of performance security.
- ii. The Dealer/firm shall not be allowed to insert/delete/ change any terms and conditions in the Agreement Deed. If any deviation is found in the Agreement Deed, it will entail termination of the contract without prejudice to the rights of the Jammu & Kashmir Medical Supplies Corporation Ltd. and any consequential loss will be recovered from the contractor.
- iii. The incidental expenses of execution of Agreement/Contract shall be borne by the successful bidder.
- iv. The conditions stipulated in the Agreement/Contract should be strictly adhered to and violation of any of these conditions will entail termination of the contract without prejudice to the rights of the JKMSCL and any consequential loss will be recovered from the contractor.

## **VII. IMPLEMENTATION / DELIVERY SCHEDULE:-**

- i. The Dealer/firm shall be required to supply a complete sample for PE Kit (containing one T- shirt, Cap & Badge each) of specified material/ design along with packing material for final approval within 07 days from the date of issue of supply order.
- ii. The Dealer/firm shall be required to supply the Peer Educator Kits within 15 days from the date of approval of sample by JKMSCL.
- iii. The participating bidders shall give their acceptance to strict adherence to the supply schedule in the prescribed

form with the technical bid. No deviation in the supply schedule shall be allowed in the tender and any such request shall be treated as counter condition and the tender shall be liable for rejection.

- iv. The purchase order may be increased/ decreased but no time extension will be allowed for delivery / supply if order is increased upto 10 % or less of the total supply order during course of supply of main order. However, **proportionate time will be given to the firm,** , in case :
  - a) the order is increased by more than 10 % of the total supply order during course of supply of main order.
  - b) extended order is given after supply of main order.
  
- v) The Peer Educator Kits shall have to be delivered FOR Corporate Office, Jammu at Plot No 09, Transport Nagar, Narwal, Jammu Tawi ( J&K) 180006

#### **VIII. ASSIGNING OF TENDER IN WHOLE OR PART:-**

The Dealer/firm shall not assign or make over the contract, the benefit or burden thereof to any other person or persons or corporate body. No under letting or subletting to any person or corporate body for the execution of the contract or any other part thereof is permitted under any circumstances.

#### **IX. PAYMENT:-**

- a. Payment for supply of Peer Educator Kits shall be made within 30 days of raising of invoice after successful completion of supply order.
- b. The supplier shall provide all bills in triplicate.

## **X. PENALTIES:-**

- I. If the entire quantity of Peer Educator Kits is not supplied within stipulated time from the date of issue of supply order, a penalty @ 2% of the cost of unsupplied PE Kits shall be imposed per week of delay upto 04 weeks. There after Performance Security shall be forfeited and a penalty @ 20% of the cost of unexecuted supply shall be imposed. The said penalty shall be deducted from any payment due to the supplier by JKMSCL.
- II. The quality of material/ designing of Embroided logo/ packaging of the PE Kits shall be strictly as per specifications and samples approved by JKMSCL. Any minor deviation from the specifications or approved sample shall attract penalty @ 2% of the contract value per parameter of deviation. However, in case of major deviation / omission, penalties under Sec X (IV) & (v) shall be imposed, in addition to termination of the contact.
- III. In the event of furnishing of any false/incorrect information by any bidder, the EMD in respect of such bidder shall be forfeited & the contractor is liable to be blacklisted for period of 02 years. Further during the performance of the contract if it is discovered that the contract has been obtained by furnishing any false / incorrect information in the tender, the agreement is liable to be terminated and performance security and other payments due to the contractor shall be forfeited. Further, depending upon the gravity of the false/incorrect information, the contractor is liable to be blacklisted for a period of 02 ó 05 years.
- IV. If the successful bidder fails to sign the agreement within stipulated time or after signing the agreement, fails to perform any contractual obligation, the EMD/SD deposit mentioned above will be forfeited.
- V. If the success bidder violates / omits any of the tender agreement conditions during the performance of the contract,

depending upon the gravity of the violation/omission, the contractor is liable to be blacklisted for a period of 02 - 05 years.

**XI. POWER OF ACCEPTANCE, REJECTION AND WITHDRAWAL OF TENDER:**

- a) The power for final acceptance of the tender would entirely vest with the Managing Director, JKMSCL, who reserves the right to accept and reject any or all tender without assigning any reason whatsoever. There is no obligation on part of the Managing Director / GM (TIA) to enter into any correspondence with unsuccessful bidders. After acceptance of the tender by Managing Director, JKMSCL, the bidder shall not have the right to withdraw the tender or claim higher price.
- b) Tender with incomplete information is liable for rejection.

**XIII. Dispute Resolution:**

- i. In case of any dispute, the decision of Managing Director, JKMSCL shall be final and binding.
- ii. In case the parties are aggrieved with the decision of Managing Director, he / she / they may refer the dispute for arbitration for which the arbitrator shall be appointed with the mutual consent of both the parties. The arbitration proceedings shall be governed by J&K Arbitration & Reconciliation Act.
- iii. Any legal dispute shall be within the jurisdiction of Honøble High Court of Jammu /Srinagar( J&K).
