In continuation to e-bid uploaded for the finalization of Annual Rate contract for Procurement of "**Lab Kits and Logistics (2025)**" uploaded vide No. JKMSCL/RTPCR/2025/662 DATED 27-05-2025, Pre-Bid Meeting of which was scheduled for 05-06-2025 At 11:00 A.M, following changes are made in the tendered specifications on the recommendations of the concerned user Department:

1. Viral RNA Extraction Kit

Please Read

The extraction kit should be able to work on manual platform

Instead of

The extraction kit should be able to work on manual as well as automated platform both.

Automated Viral RNA Extraction Kit Compatible with Genetix HT Purifier 96 DNA/RNA Purification System is being floated separately.

2. Dual test kit for HIV and Syphilis kit

Please Read

The assay component should include a sufficient volume of positive and negative controls for conducting 10% of the tests as per pack size

Instead of

The assay component should include a sufficient volume of positive and negative controls for conducting 20% of the tests as per pack size appearing at Sr. 9(c)

Please Read Sr. No. 16 The clinical performance evaluation data of the kit on the whole blood sample should be made available by the manufacturer as deleted.

3. Elisa Based Dengue NS1 Kits

Please Read Sr. No. 04, The ELISA kit for detection of dengue NS1 Antigen should have a sensitivity of $\geq 90\%$ taking RT-PCR as the gold standard and a specificity of $> 95\%$ taking RT-PCR as the gold standard.

Instead of

The ELISA kit for detection of dengue NS1 Antigen should have a sensitivity of $\geq 90\%$ and a specificity of $\geq 95\%$ taking RT-PCR or ELISA as the gold standard.

4. Qualitative RT-PCR Kits:

Please Read Sensitivity of the Kit as 98.5% or more
instead of 100%

5. In addition to above, a Separate **Tender ID No: 2025_HME_277801_14** has been created for submitting rates of Automated Viral RNA Extraction Kits, compatible with Genetix HT Purifier 96 DNA/RNA Purification System which is being used in

many GMCs of J&K. Kit should be evaluated and validated by ICMR-NIV-Pune or equivalent institute of ICMR.

6. Please note that separate Tender IDs (from 2025_HME_277801_1 to 2025_HME_277801_14) have been generated to enable bidders to quote rates on an item-wise basis. However, for all items covered under NIT No: JKMSCL/RTPCR/2025/662 dated 27-05-2025, bidders are required to submit only **one Tender Fee, one Tender Processing Charge, and one EMD**, regardless of the number of items they choose to quote for under the said NIT

Financial Bids of only those bidders shall be considered for opening after being recommended by the Technical Experts, from the concerned Department, out of the bidders recommended by the subcommittee after evaluation of Technical Bids and acceptance of Technical Evaluation/Advisory Committee.

In case of any default by the bidder, at any stage of tender or subsequent approval by JKMSCL, for a particular items/s, the Disciplinary Committee/ any other committee constituted for the purpose shall be at liberty to take appropriate action as per provisions of Standard Procurement Procedures (SPP) and / or Policy for Blacklisting of JKMSCL.
