Sub:- Revision of GST on Approved Rates of Machinery & Equipment and Surgical Instruments etc. – Effective from 22.09.2025.

In continuation to the existing Rate Contract(s) for supply of Machinery & Equipments & Instruments concluded by JKMSCL, it is hereby informed that consequent upon revision of Goods and Services Tax (GST) rates by the Government of India, the applicable GST on Medicines/ Medical Devices/Surgical Dressings etc. has been revised with effect from **22nd September, 2025**.

Accordingly, the approved rates under active Rate Contracts against various NITs for the Group "Machinery & Equipment and Instruments" **are hereby revised** to incorporate the **revised GST component** as notified by the Government. This shall be applicable to list of items attached as well as the approved rate contracts issued by JKMSCL under Group Machinery and Equipments, Dental Equipment and allied items.

1. The revised GST shall be applicable **only from 22.09.2025 onwards**, and supplies made prior to this date shall be governed by the previous rate of GST.
2. The **basic approved rates** shall remain unchanged. Only the **GST component** shall be adjusted in accordance with the revised GST rates.
3. It is enjoined upon all the supplier firms to ensure that the **invoices and billing documents** reflect the revised GST rate correctly as per statutory provisions.
