

**MINUTES OF MEETING**  
**CONSIDERATION OF TECHNICAL BIDS**

**22-08-2025, 11:00 A.M**

**Sub:** Consideration of Technical Bids of tenders invited for procurement of **"Ayurvedic/ Unani Classical & Patient Medicines"** Uploaded vide No: JKMSCL/AYD/UNANI/MED/2025-2027/666 Dated: 23-06-2025.

1. e- Bid for the finalization of Rate Contract for the procurement of **"Ayurvedic/Unani Classical & Patient Medicines"** Uploaded vide No: JKMSCL/AYD/UNANI/MED/2025-2027/666 Dated: 23-06-2025.
2. As per tender notification Pre-Bid meeting was held on scheduled date i.e. 03-07-2025 at 11:00 A.M at Corporate Office Jammu and Srinagar. A corrigendum was issued vide No. JKMSCL/666/Corg./656/2156-59 Dated: 09-07-2025 wherein some specification of the tendered item were amended and some items were deleted followed by another corrigendum issued vide No: JKMSCL/666/Corg./223-26 Dated: 16-07-2025 where under 18% GST was mandatory on Tender Fee and Processing Charges. It was observed that few items have been inadvertently tendered under NIT 666 and accordingly, they were deleted vide corrigendum No: JKMSCL/666/Corg./2292-95 Dated: 19-07-2025.
3. e-bids were opened on 24-07-2025 at 11.00 A.M; in the presence of Technical Evaluation Committee constituted by Boards of Directors during 1<sup>st</sup> Board Meeting and amended by Boards of Directors during 3<sup>rd</sup> Board Meeting, JKMSCL for the purpose, and as per the system generated report, 32 bidders participated for various items tendered in the mentioned NIT. Details are as under:

4. After the opening of e-bids, compilation, preliminary scrutiny and evaluation of bid documents was carried out by the Technical Evaluation Sub Committees constituted for the purpose. After evaluation of technical bids, subcommittee submitted its report, indicating some documents which were found deficit as per the requirement of NIT.
5. Accordingly, vide Notice No: JKMSCL/GM(K)/2025/2573-77 dated 08-08-2025, the bidders were asked to submit the deficit documents pointed out by the subcommittee latest by 18-08-2025. Documents, thus submitted by the bidders were again scrutinized by the committee and a final report was submitted on 20-08-2025. As per report following bidders were not recommended to TEC for further process and the reasons for non-recommendation is mentioned against each bidder:

4	M/s Gulmarg Herbal Remedies Budgam, Kashmir (MSME) (Bidder/Manufacturer)	Bidder/Manufacturer was not recommended for not submitting Turn over & Balance sheet for the year 2021-22 as asked in NIT
5	M/s Indo Himalayan Herbs Inc Haryana (MSME) (Bidder/Manufacturer)	Manufacturer/Bidder was not recommended for not submitting Latest Market Standing Certificate issued by Chartered Accountant not Less than three preceding Years mentioning the quoted items.
6	M/s PT Madho Lal Zind Lal & Co., Jammu (Bidder) M/s Rex Remedies Ltd, Delhi (Manufacturer)	As per Notice Inviting Bid (NIB) it is clearly mentioned that "The bidders seeking EMD exemption must submit the valid supporting document for the relevant category. Under MSE category only manufacturers for goods and service providers for services are eligible for exemption from EMD. Traders are excluded from the purview of this Policy". Contrary to this M/s PT Madho Lal Zind Lal & Co., Jammu (Bidder) failed to submit EMD and sought EMD exemption on the plea that the manufacturer offered by them is MSME, which is not permissible as per NIT. Therefore, the bid was not recommended.









6. Rest of the bidders were declared qualified on the basis of evaluation of Technical Bid Documents by the sub-committee.
7. Technical Evaluation Committee also took note of supplementary recommendations made by sub-committee towards minor infirmities offered by M/s S S Agencies on behalf of manufacturer M/s SG Phyto Pharma Private Limited Kolhapur and accepted the same in order to promote healthy competition among bidder
8. The Technical Evaluation/Advisory Committee in its meeting held on 22-08-2025 accepted the Sub-Committee report mentioned above and it was unanimously decided that teams be constituted for the Inspection of the recommended manufacturing units except manufacturers which are already approved with JKMSCL and also except those firms which have failed in the previous inspections conducted by JKMSCL as per clause 2.5.6 of SPP.
9. It was also decided that:
  - I. The firms/manufacturers which qualify in the physical inspection and the firms/Manufacturers already approved with JKMSCL shall be asked for submission of samples as per NIT, for evaluation by experts from AYUSH specialty for their recommendations. The report /recommendations by the sample selection committee shall be placed before the Technical Evaluation /Advisory Committee in its next meeting for further necessary action.
  - II. While asking for samples from the eligible bidders, the bidder firms shall be asked to submit a fresh undertaking duly notarized on Rs. 100/= (One hundred) stamp paper that they are not disqualified by Tamil Nadu Medical Supplies Corporation or Kerala Medical Supplies Corporation or Rajasthan Medical Supplies Corporation or any other premier institution, in the factory inspection during preceding year, as per clause 6.2.12 of SPP



III. The Composition of teams for the inspection of Firms/ Manufacturers shall be as such that each team constituted shall have at least one member from each of the following organizations/Departments.

- (i) Drugs & Food Control Organization J&K,
- (ii) Directorate of AYUSH J&K.
- (iii) JKMSCL
